Notes:

- 1. Shipment volume of handset lens sets increased by 38.9% YoY, mainly due to the increased market share of Company's handset lens sets; It decreased by 5.7% MoM, mainly due to the National Day Holiday.
- 2. Shipment volume of vehicle lens sets increased by 33.5% YoY, mainly due to the rapid development of vehicle imaging field and the Company's increasing global market share when compared to the same period of last year.
- 3. Shipment volume of handset camera modules increased by 11.9% YoY, mainly due to the increased market share in domestic smartphone market.
