The shipment volume of handset lens sets decreased by 26.0% YoY, which was mainly due to the high base of shipment volume in the same period of last year and the current ongoing weak demand from the overall smartphone market; It increased by 21.0% MoM, which was mainly due to the low base of shipment volume in January because of the Spring Festival Holiday.
2. The shipment volume of vehicle lens sets increased by 39.7% YoY, which was mainly due to the increased demand from the vehicle camera market caused by the relief of the key components in the auto supply chain.
3. The shipment volume of handset camera modules decreased by 39.2% YoY, which was mainly due to the high base of shipment volume in the same period of last year and the current ongoing weak demand from the overall smartphone market; It decreased by 25.7% MoM, which was mainly due to the customer's request for shipping partial products in January in advance.
