2. The shipment volume of vehicle lens sets decreased by 13.1% MoM, which was mainly due to the inventory control by customers at the end of year.
3. The shipment volume of handset camera modules increased by 49.9% YoY, which was mainly due to the low base caused by the weak demand from the overall smartphone market in the same period of last year.
