1. The shipment volume of handset lens sets increased by 14.6% YoY, which was mainly due to the weak demand from the overall smartphone market in the same period of last year, and the increased market share of the Company in high-end products.
2. The shipment volume of handset camera modules decreased by 25.2% YoY, which was mainly because the Company focused on mid- to high-end projects and thus the product mix improved significantly compared to the same period of last year.
